Maintenance/Clean-up

- All vendors are required to maintain the cleanliness of his/her vendor space.

Promotion Name & Logo

- Any material containing the copyrighted City of Pompano Beach, Browns Community Development Center, Inc. Or the “5th Annual Collier City Family Fun Day” names and logos are prohibited for use or sale.
- The use of generators is permitted with Vendor Coordinator approval. Power cords must be taped down.

Items to be Sold or Distributed

One exhibitor is allowed per space. Upon signing this contract, vendors must provide a list of all the items to be sold or distributed and adhere to items listed.

Liability and Insurance

- **All Food vendors must provide a copy of his/her food permit, Food Handling Certificate and a copy of your Business license.** Upon signing this contract, vendor participates in this event at his/her own risk. In case of inclement weather or other Acts of God, vendor agrees to accept full responsibility for profits or loss or any missing, stolen items or damage to person or personal property

Damages

- If damage to public property is incurred by vendor or vendor representative participating in the event, he/she will be held liable for the repair or replacement of the damaged property. This applies to, but is not limited to, such items and areas as exterior fencing, structures, drinking fountains, irrigation equipment, trash cans, landscaping, tents and any other facilities or equipment at the **McNair Community Park, Pompano Beach, Florida**
